### **Prize Draw terms and conditions**

1. These terms and conditions together are the Prize Draw Rules and apply to this Prize Draw. By registering a qualifying journey at 2carshare.com you are agreeing to enter the Prize Draw unless you have sent an email to [sustainable.travel@n-somerset.gov.uk](mailto:sustainable.travel@n-somerset.gov.uk) with the subject line 'No prize draw' and your full name. Entrants agree to be bound by these Rules.
2. The Prize Draw is organised and promoted by North Somerset District Council.
3. The Prize is 12-months car / cycle breakdown service, to the value of £100, offered by the Environmental Transport Association.
4. North Somerset District Council has the right to cancel this Prize Draw or the Rules without notice, at any stage, if deemed necessary in its opinion, and if circumstances arise outside its control. Any changes will be posted either within these terms and conditions.
5. In the event of any dispute regarding the Rules, conduct, results and all other matters relating to a Prize Draw, the decision of North Somerset District Council shall be final and no correspondence or discussion shall be entered into.

7. Entrants must be aged eighteen years or over. The Prize Draw is only open to residents of the United Kingdom.

### **Entries**

8. Entrance is based on registering as a new user at [www.2carshare.com](http://www.2carshare.com) and registering a journey from the entrant's principle home address to their principle workplace address from December 1<sup>st</sup> 2011 to January 31<sup>st</sup> 2012. Either the home address and / or the workplace address must be within the district of North Somerset. An entrant who has previously registered at [www.2carshare.com](http://www.2carshare.com) will be eligible for the prize draw provided they de-registered from 2carshare before the 31<sup>st</sup> October 2011.

9. The prize draw is not open to employees of North Somerset Council's Highways and Transport Section and Corporate Services Unit.

10. Only one entry may be made per person. An entrant may not make multiple registrations on [www.2carshare.com](http://www.2carshare.com) by using alternative email addresses. If North Somerset District Council discovers or has reasonable grounds to believe the winner has used any software or automated process to make bulk registrations, North Somerset District Council may select an alternative winner. Any further winner will be selected on the same criteria as the original winner and will be subject to these Rules.

11. Prize Draw entries must be made in the manner and by the closing date and time specified on the Prize Draw Notice. Failure to do so will disqualify the entry.

### **The Prize Draw**

12. The prize draw will be carried out on or before 1<sup>st</sup> March 2012 and the winner will be selected at random from all qualifying entries.

13. The winner will be notified by email, to the email address they have registered at [www.2carshare.com](http://www.2carshare.com), so please make sure this is correct.

14. When the winner is notified they will be asked to confirm their acceptance of these terms and conditions before being provided with the prize, within 14 days of the email being sent. If North Somerset Council (by reply to the email address; [sustainable.travel@n-somerset.gov.uk](mailto:sustainable.travel@n-somerset.gov.uk)) does not receive acceptance to these terms and conditions within this time, or the notification email is returned as undeliverable, the first drawn winner may be disqualified. Then the prize will be drawn at random again and offered to an alternative winner.

North Somerset District Council cannot accept responsibility for non-delivery or receipt of any email due to error, omission, interruption, deletion, email filing systems, defect, delay in operation or transmission, communications line failure, theft, destruction, alteration of or unauthorised access to Registrations, or Registrations lost, damaged or delayed as a result of server functions, technical issues, virus, bugs or other causes outside North

Somerset District Council's control. Any decision over the final winner is final and any correspondence or discussion into this will not be entered in to.

16. North Somerset District Council reserves the right not to award a prize (and to select an alternative winner) if North Somerset District Council is aware or has reasonable grounds to believe that a winner is not eligible.

17. By entering the Prize Draw, you hereby warrant that all information submitted by you is true, current and complete. North Somerset District Council reserves the right to verify the eligibility of all entrants.

18. North Somerset District Council reserves the right to disqualify any entrant if it has reasonable grounds to believe the entrant has breached any of the Rules.

19. In the event that any entrant is disqualified from the Prize Draw, North Somerset District Council in its sole discretion may decide whether a replacement should be selected. In this event, any further entrant will be selected on the same criteria as the original entrant and will be subject to these Rules.

North Somerset District Council cannot accept any responsibility for any damage, loss, injury or disappointment suffered by any entrant entering the Prize Draw or as a result of accepting any prize. North Somerset District Council is not responsible for any problems or technical malfunction of any telephone network or lines, computer on-line systems, servers, or providers, computer equipment or software, failure of any email or entry to be received on account of technical problems or traffic congestion on the Internet, telephone lines or at any web site, or any combination of these, including any injury or damage to entrant's or any other person's computer or mobile telephone related to or resulting from participation or downloading any

materials in the Prize Draw. Nothing shall exclude North Somerset District Council's liability for death or personal injury as a result of its negligence.

Data relating to entrants will be retained by North Somerset District Council for a reasonable period after the Prize Draw closes to assist North Somerset District Council to operate the Prize Draw in a consistent manner and to deal with any queries on the Prize Draw.

### **Jurisdiction**
