

LEVEL A – “Area Wide” rules [\(about this PSPO\)](#)

On "any land to which the public is entitled or permitted to have access with or without payment" it is proposed that it will continue or become an offence to:-

1. Fail to remove dog faeces
2. Fail to produce a receptacle for picking up dog faeces
3. Fail to put a dog on a lead when required to do so
4. Deposit litter
5. Urinate or defecate in any place other than in a public convenience
6. Fail to move on when requested to do so by an authorised officer
7. Undertake any form of commercial activity, on public property, without the written permission of the council
8. Post a notice or sign, on public property, without the written permission of the council
9. Fail to stop consuming intoxicating substances when asked to do so
10. Fail to surrender intoxicating substances when asked to do so

LEVEL B – “All Parks and Open Spaces” rules [\(about this PSPO\)](#)

In any “public park, common, pleasure ground and beach” it is proposed that it will continue or become an offence to:-

1. Ride a horse unless on a public bridleway or public highway with the exception of beaches (does not apply to working police horses)
2. Park or drive a vehicle without the express written permission of the council
3. Skateboard, ride a scooter, hoverboard, roller blade or inline skate in a way that may damage property or as to cause annoyance and/or nuisance
4. Light an open fire without the written permission of the council

LEVEL C – “specific types of property” rules

In any “[enclosed children’s play areas](#)” it is proposed that it will continue or become an offence to:-

1. Allow a dog in an enclosed children’s play area
2. Smoke tobacco or tobacco related products [\(more about this PSPO\)](#)

In any “[public museum](#), [library](#), [public convenience](#) or [council building](#)” it is proposed that it will continue or become an offence to:-

1. Engage in behaviour as to damage to property, nuisance and/or annoyance [\(more about this PSPO\)](#)

In any “[council managed designated parking area](#)” it will continue or become an offence to:-

1. Deposit or leave any vehicle or trailer with the purpose of abandoning it there
2. Act in a manner as to damage to property, nuisance and/or annoyance to any parking place user, resident or other person
3. Distribute leaflets or other advertising material or promote any cause, event or any other matter [\(more about this PSPO\)](#)

LEVEL D – “specific public open Spaces” rules [\(about these PSPOs\)](#)

In places where Dog Control Orders already exist and there is no intention to amend them, they will transfer into Public Space Protection Orders [\(about former DCOs\)](#)
