The above Order, made on 4 October 2019, under section 119 of the Highways Act 1980, will divert part of Public Footpath LA 8/28 in the Parish of Easton-in-Gordano within the District of North Somerset - Public Footpath LA 8/28 from point A (grid reference ST 52785 74533) in a south easterly, then easterly direction for approximately 60 metres to point B (grid reference ST 52830 74500). This proposal is shown on the Order Map No. PPO 188. The footpath will have a stoned surface and a width of 1.5 metres.
